The **mission** of the Civil Protection Voluntary Teams is to provide assistance to the competent authorities in safeguarding the lives, health and property of citizens, as well as the environment and the cultural heritage from impending or ongoing natural, technological, or human-made disasters and threats that give rise to emergency situations during times of peace.

The Civil Protection Voluntary Teams are part of the National Civil Protection Mechanism and actively support the initiatives of the competent authorities and state services in fulfilling their mission, all in alignment with the principles of social solidarity.

#### **Civil Protection Volunteerism in Greece: A Brief Overview**

Formally established in 2002 by Law 3013, that:

- > Introduced the role of Voluntary Teams within the Civil Protection System.
- ➤ Outlines their legal structure.
- ➤ Indicates the phases in which volunteers can be involved (Prevention, Preparedness, Response, and Rehabilitation).
- > Outlines the financial mechanism.

The total number of Voluntary Teams registered in the national Registry by March 2020, was about 580 with a total number of members over 12.000.

The main criteria to be registered were based on:

- Confirmation by state competent bodies for their participation in civil protection actions.
- Confirmation of training received from various governmental or non-governmental or organizations, such as the Fire Service (Forest Protection, Forest Fire Fighting, Search and Rescue), First Aid Service, Red Cross.
- The scientific and professional qualifications of their members (doctors, nurses, psychologists, sociologists, etc.).

#### **Upgrading the Civil Protection Volunteerism System: Law 4662/2020**

The recognition of specific weaknesses in the regulatory framework, including mainly

- inadequate and incomplete training,
- > absence of certification of volunteers skills,

prompted the reformation of the Civil Protection Volunteerism System in 2020 under the Law 4662.

Voluntary Teams that had already been registered, were invited in 2022 to submit supporting documents according to the new criteria and conditions if they wished to join the new System.

There is also an open invitation for new teams to participate.

Today, a year later approximately **300 teams with over 6.000 members** have expressed interest in becoming part of this vital initiative.

# Civil Protection Volunteerism Registry

Kept by the Directorate of Volunteerism and Education at the General Secretariat of Civil Protection Consists of <u>3 individual sub- registries and 2 Archives</u>:

- Registry of Civil Protection Voluntary Teams: to which Teams that meet specific criteria are registered
- Registry of Civil Protection Volunteers: includes the members of the Registered Voluntary Teams that meet some essential attributes
- Registry of equipment: includes the means and materials of the Registered Voluntary Teams
- \* Archive of organizations and entities collaborating with the General Secretariat of Civil Protection
- **Archive of the Evaluation Reports** *for the Registered Voluntary Teams*

A **Voluntary Team** in order to get registered in this new Civil Protection Registry must be a national Non-governmental Team that:

- has a non-profit nature,
- has a charter where is stated the aim of participation on situations related with civil protection
- has at least twelve (12) members that accumulate all the essential attributes for being entitled as certified Civil Protection Volunteers.

#### A member of a Voluntary Team must:

- have Greek nationality or permanent living in Greece
- speak and write the Greek language sufficiently
- has reached the age of 18 years old and not to exceed the age of 65 years old for operational actions and 70 years old for supportive actions
- be provably in good physical and mental health, certified by medical reports from doctors specialized in pathology, cardiology and psychiatry
- has a clean criminal record
- receive successfully the required certified training

#### Reasons why a Voluntary Team may be deleted by the Registry:

- culpable, not in time or unfruitful correspondence of a Voluntary Team to a call out or mischief in the cooperation with the General Secretariat of Civil Protection or the operational bodies involved
- arbitrary non appearance or misconduct or misdemeanor implementation during the duties by members of a Voluntary Team
- arbitrary adoption of national or supranational operational action, apart from the official operational planning and orders of the responsible organization
- exercise or covert pursuit of profit-making activity of the Voluntary Team
- the Voluntary Team hasn't been active for more than 2 years.
- no compliance with safety rules by the members of the Voluntary Team during the performance of their duties
- declaration of inaccurate or unreal facts concerning the Teams and their members to the General Secretariat of Civil Protection



# **Involvement of Voluntary Teams in operational planning.**

#### ADMINISTRATIVE LEVELS OF INVOLVEMENT AND THEIR ROLE

Central/ Governmental level: General Secretariat of Civil Protection is responsible for the organization, update, supervision and upgrade of the Civil Protection Volunteerism Register (E.M.E.P.P.). The role, also, includes the promotion and support of volunteerism, the certified training of volunteers and the undertaking of appropriate measures to improve the institutional and regulatory framework.

Regional Operational level: 13 Regions. Each Region is subdivided spatially and administratively into Regional Units. There are 74 Regional Units throughout the country.

**Local Operational level:** 322 Municipalities



# 13 Regions74 Regional Units

Each Voluntary Team is involved in the Regional Unit level or Local level operational planning according to the spatial range of action, as well as the specific actions that are determined in the Registration Act.

#### I. Regional Operational level: Civil Protection Regional Unit Coordinating Body (S.O.P.P.)

The role of the Civil Protection Regional Unit Coordinating Body (S.O.P.P.) is to support the work of the Vice-Regional Governor for the availability, disposal and coordination of all the necessary resources and means for the preparedness, response and restoration actions in the Regional Unit to which it belongs.

The **members of the Body** are the Heads of the Civil Protection Directorates of the relevant Region and Regional Unit and the representatives of all regional authorities and services depending on the Risk and their responsibilities.

Concerning Flood Risk, representatives come from the Infrastructure sector, the Agricultural development sector, the Health sector, the Fire Service, the Police, First Aid Service etc.

**Volunteer Teams** that are registered and act in each Regional Unit are also **members** of the Coordinating Body of the Unit and must provide information regarding:

- > The number of their members who can participate in each specific activity.
- ➤ Their temporal availability.
- > The action area.
- > The means they can provide.

II. Local Municipality Operational level: Local Civil Protection Coordinating Bodies (S.T.O.).

At the local Municipality level, the Local Civil Protection Coordinating Body (S.T.O.) has the same role and responsibilities for the support of the Mayor in the Municipality preparedness and emergency planning.

Also in this case Voluntary Teams registered and act in each Municipality are members in the Local Coordinating Body with similar role and responsibilities as above.

#### **COORDINATION OF VOLUNTARY TEAMS**

The coordination of the Voluntary Teams which participate in actions, as these have been identified in Regional Unit or Local Civil Protection Coordinating Bodies, is done by the Civil Protection Directorate of the Regional Unit or the Civil Protection Department of the Municipality.

# i. Preparedness Activities of Volunteer Teams (in regard to Flood Risk)

- > Participation in Regional Unit or Local Coordinating Bodies as described above.
- ➤ <u>Public Awareness Activities</u>: Assisting local authorities in informing and raising awareness among citizens to take preventive and self-protection measures against risk.
- ➤ <u>Telecommunications Activities:</u> Participation in the communication and information flow system checking to ensure the ability to securely exchange information between the involved Agencies.
- ➤ <u>Participation in training programs and exercises</u> organized by the Civil Protection Agency of the Region or the Municipality to deal with flood risk.
- ➤ <u>Maintenance of the equipment and vehicles</u> they will provide to deal with emergency needs from floods.

#### ii. Response Activities of Voluntary Groups (in regard to Flood Risk)

- > Search and Rescue operations: Support the responsible Authorities in locating, assisting, extricating and rescuing citizens in danger.
- ➤ Aid and Support Actions: a) Water Pumping, b) Animal Release and Rescue.
- First Aid Actions: Exclusively by volunteers doctors or nurses.
- ➤ Relief and Support Actions and Transportation Actions: Assistance of the Regional or Municipal services in the transport of people and materials, in the organization and operation of shelters, for accommodation and feeding of the affected population. Undertaking psychological support actions should be only by volunteers who are professionals (psychologists or sociologists).
- > Actions to inform citizens for preventive evacuation measures:
  - Support local authorities and Police to inform the citizens door to door about the risk that they run if they remain in the area, providing the required information about safe routes to safe places.
