▶ Role of Civil Protection:

- Civil Protection refers to the actions and measures taken to prevent, prepare for, respond to, and recover from disasters, both natural and man-made.
- It is essential at national and local levels for ensuring the safety, security, and resilience of communities during emergencies.

Natural Disasters: Focuses on disaster management for earthquakes, floods, wildfires, and other environmental risks.

Man-Made Hazards: Manages risks related to industrial accidents, chemical spills, nuclear incidents, and other human-induced disasters.

- Collaborations: Partners with research centers, universities, and international organizations like UNDRR and EUCPM.
- **Benefits:** Gains global expertise, shares best practices, and collaborates on joint research and training.

- Objective: Conduct risk assessment of forest fires in the Georgia-Azerbaijan region.
- Actions:
 - Collaborations with national authorities to strengthen forest fire risk management.
 - Development of forecasting models to predict and mitigate forest fire impacts.

- Will contribute to Host Nation Support (HNS) Revision with the Cross Border element.
- Project will report on training events at all borders of the partners, the challenges still remaining and the need for the national policies/improvements to be aligned with/ and diffused to local bordering areas.
- Although we engaged most key stakeholders in discussions/training, we missed the private sector and media.
- There is a gap in linking civil protection activities to local/border policies and action plans.
- ROSES understood the driving forces to make civil protection priority at border areas (become a pillar that links disaster risk reduction and resilient activities with development and social policies, practically securing the benefits of any cross border cooperation policy).

Select 3 border areas to work with

- 1. common risk assessment,
- 2. common operational picture,
- 3. joint (both countries) communication campaigns to strengthen the existing informal cooperation,
- 4. conduct 2 small scale exercises at each border (early as diagnostic tool and later to verify work done),
- 5. create a joint crisis management plan and joint action plan, exploiting further bilateral projects,
