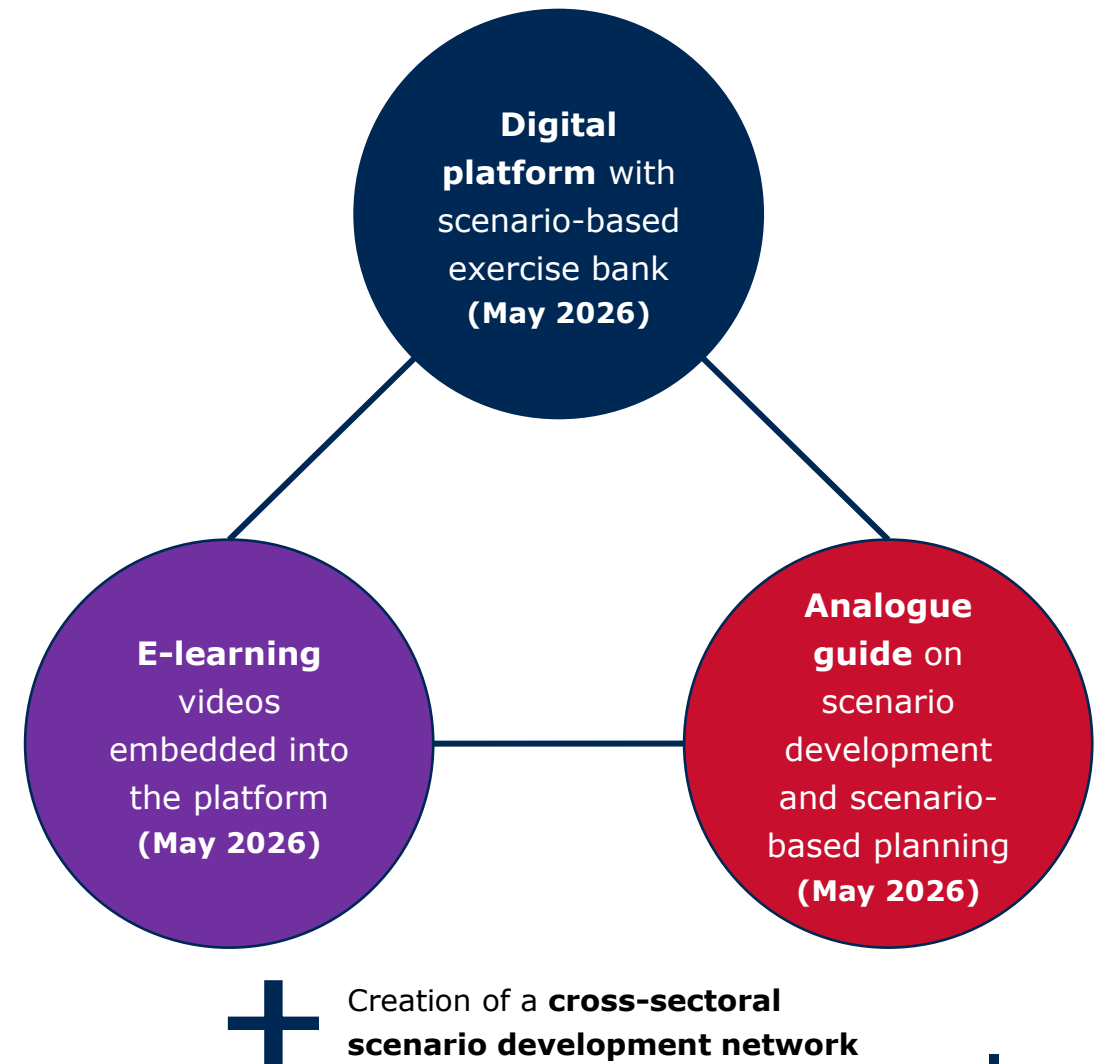
Title:	Scenario and Exercise Bank (SCENEX-B)
Sole beneficiary:	Danish Resilience Agency
Total eligible costs:	442,815.40 EUR (EU co-financing: 420,659.12 EUR)
Duration:	February 2025-January 2027 (24 months)

Background for SCENEX-B

- Since 2020, Danish public authorities have been increasingly interested in scenario-based planning (e.g., 2022 NOST planning, scenario-based planning in fall 2024)
- Desire to make the NRA more user-friendly
- Implementation of the Disaster Resilience Goals
- **A qualified basis for advising public authorities in their scenario-based planning efforts**

Outputs

- Supplement to the Danish NRA (NRP)
- Concrete outputs (expected May 2026):
 1. Scenario and exercise bank with 2-4 scenarios per key risk (incident type) + consequence-coded injects that can be used for exercise planning – regular updates (1-2x annually)
 2. E-learning videos to support users in navigating and using the scenario and exercise bank and development of tabletop exercises
 3. Analogue scenario development and scenario-based planning guide (approx. 10 pages)

- **Workshop 3:** scenario development method to be formalised in a written guide

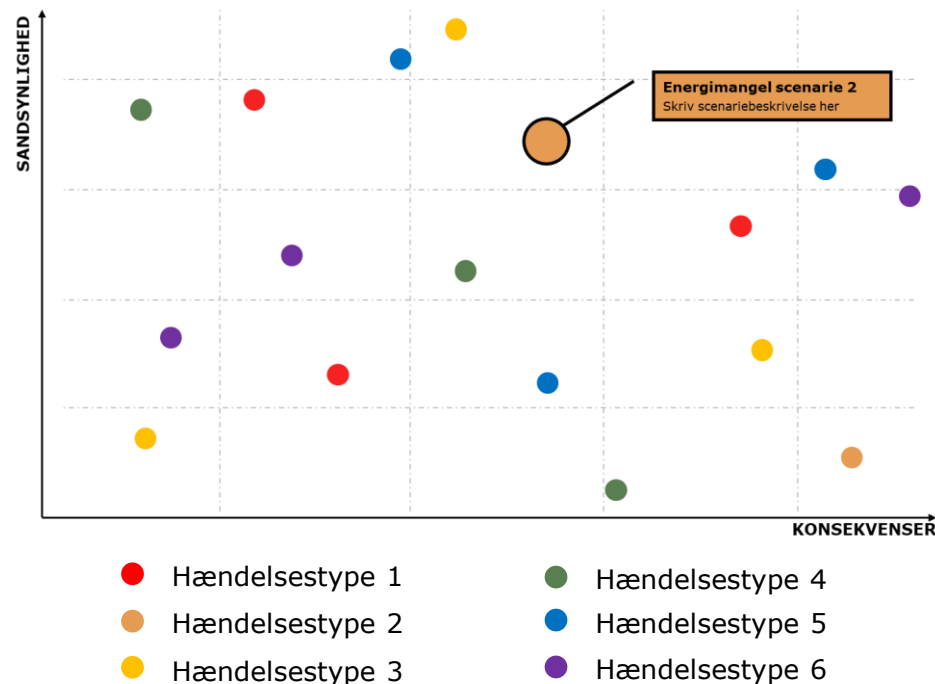

Nationalt Risikobillede: scenariebanc



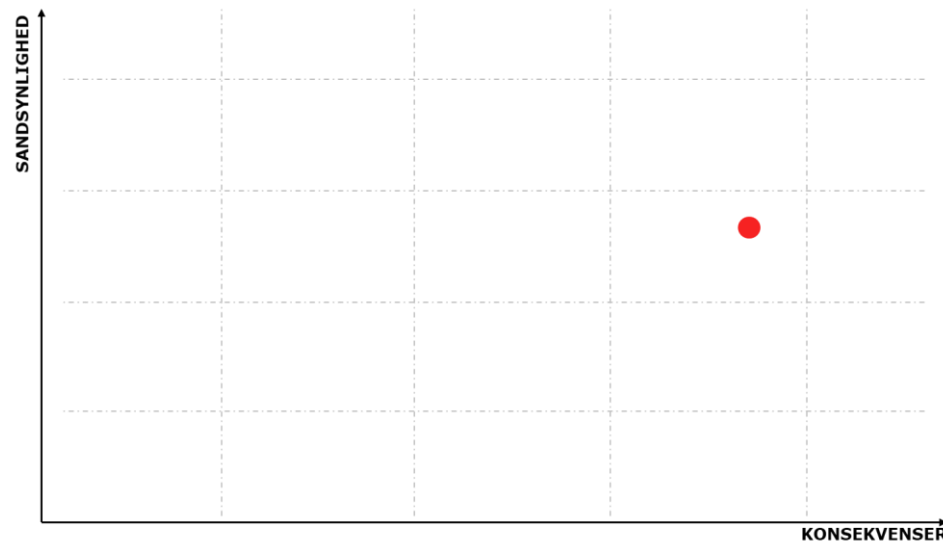

FUNCTIONALITY:

- Mouse over dots in the matrix to reveal previews of scenarios (see orange dot example)
- Each dot in the matrix functions as a hyperlink to a scenario page
- Ability to select incident type and isolate those dots on the matrix
- Guiding instructions underneath the scenario bank
- Several ways to navigate to the scenario pages – directly via the matrix or by navigating via the incident type pages
